Message from Mayor Gary Johnson



Hello Residents!

I would like to express my greatest gratitude on being elected as Mayor and becoming the first African American male in the history of Jennings. “The Great City of Jennings” is now on a path to create neighborhood stability and economic growth, that will prepare us for future sustainability. Under the new administration, the City Service Department and Human Resource Department were created. The two departments are

very important in the city’s mission to improve processes and resources for residents. After the position sat vacant for almost three years, the council approved the hiring of a Finance Director.

Economic Development:

1. This administration’s goal is to create a better sense of community for its residents, while providing opportunities to obtain the great necessities within the city’s borders and boundaries. One declining factor of our community is the vacant and abandoned properties. To combat and tackle this issue, the Vacancy Task Force has been created. The task force has mapped and identified all vacant properties in the city limits. The data and information gathered is compiled to determine the availability or opportunity for acquisition.
2. Providing migration opportunities that attract new small businesses and supporting current small businesses will be intentional and deliberate.
3. After taking office in April, demolition began on the south end of the city. The effort to rid the community of derelict and “run-down” houses will be an ongoing process.

Employee Morale:

1. The recognition of “Employee of the Month” has been created to acknowledge and celebrate the dedication of the employees.
2. BONUS! City Employee have received two bonuses since April 2023, and more to come.
3. We will consistently celebrate special occasions, holidays, work accomplishments, and birthdays.

Within our first year we were able to provide many resources that immediately benefited the residents. We will always focus on providing resources to the community when the opportunity presents itself. The opportunity came in the form of

ARPA funding. After a few amendments, those funds are now community focused. We have provided:

1. Tree Trimming Grants
2. Emergency Relief Grants
3. Ring Doorbells
4. Verizon Wireless Hotspots

You may have noticed the Public Works Department out early in the mornings, particularly 7am-9am removing trash and debris from our community. Our PW Manager is committed to a cleaner Jennings. In some areas you also may have noticed an improvement in visibility, as overhanging tree branches were removed over city streets.

I truly encourage residential participation and involvement. Our community will only improve if we work in a collaborative manner. We want to hear from you, we want to see you! Keep an eye on our website for events and meetings. Public comments are a great source for us to know what's going on. Let's bring "The NEIGHBOR back to the HOOD".

The City Clerk is the custodian for all official City records, including ordinances, resolutions, meeting minutes, and agendas.

The City Clerk supervises the City-wide records management functions, serves as an archivist, provides information to the general public and city staff, assists the City Council in recordkeeping functions.

The City Clerk is responsible for the preparation of all municipal elections, including posting meeting notices, accepting candidate filings, and preparing the election certification. Provides a variety of routine and complex administrative, supervisory, and clerical work in the administration of the City government.

HOW TO PAY YOUR TICKET

Payment Options

> Online Payments:

You do have the option of paying some violations prior to appearing in court. To pay your violation online. You will need to go to www.courts.mo.gov and select "pay my ticket", then select "plead and pay". This may be done only up to the court date on your ticket. After that date has passed, it will no longer be pre-payable online. There is a convenience fee charged based on the amount of the ticket. Some tickets may still be paid after the first court date, just not online or by phone.

> In-Person Payments:

Some tickets are payable out of court, please click on the Defendant Resource tab for payable out of court offenses. The acceptable forms of payment are **cash, money order or cashier's check** to pay your violation in-person. Money orders and cashier checks are made payable to: The City of Jennings. (Please contact the court to verify your case before proceeding, 314-385-4670).

Jennings Department of Corrections under the leadership of Lt. Pervis Jones has undergone changes that include tablets for federal inmates, allowing them access to family and friends twenty-four hours a day with audio and video calls and text. The tablets are equipped with pre-loaded games, educational programs, the facility's rules and regulations, and the opportunity to purchase music and movies from trusted sites. We are holding officers accountable for their actions and putting safety and security first. The officers conduct regular tours of the population areas to ensure the inmates are not having medical issues and are safe. We also check for any safety hazards so they can be addressed promptly.

Corrections have One Lieutenant, one sergeant, three corporals, and ten officers, with five vacancies.

Our officers are trained in Critical Incidents (CIT) through our partnership with St. Charles County Jail. The officers are expected to be professional to the inmates and members of the public.

Although the facility is older than some other municipalities in the area, the facility is clean and safe. The inmates clean their living areas twice a day. We have yearly inspections conducted by the Federal Marshals. We are proud that for the last three years, we have passed this inspection on the first attempt.

Although no one wants to be incarcerated, we do our best to make the inmates feel safe and comfortable throughout their stay in Jennings DOC by courtesy, respect, and constant communication.

I would like to thank Officers Iren Kipkuna, Billy Mason, Petula Bell, Venus Johnson, and Corey Jones for helping the department as they have covered shortages in court, commissary, and the jail. These individuals played a big part in assisting the department as we were able to complete tasks that were needed for us to function from day to day. It is good to have team players who go above and beyond what is required of their normal assignments. Some people sit back and only do what is required, and others do what is needed. You all are this quarter's SUPERSTARS, and I want to thank each one of you for your hard work and dedication to the department, and the city of Jennings.



Twelve volunteers founded the North County Fire & Rescue Fire Protection District in March 1930, including the Reverend Joseph Westhus, Pastor of St. Catherine of Alexandria Catholic Church. On February 6, 1931, the department was incorporated into the Riverview Gardens Volunteer Fire Department. On June 10, 1944, the department was incorporated into the Riverview Fire Protection District.

In 2014, the Riverview Fire Protection District merged with the Jennings Fire Department. The men and women of Jennings Fire Department joined Riverview Fire Protection District in September 2014. The Jennings Fire Department house on West Florissant became known as House 3.

With the addition of the Jennings Fire Department, Riverview Fire Protection District now covers an area of 17 square miles. We provide service for Bellefontaine Neighbors, Flordell Hills, Glasgow Village, Village of Riverview, Jennings, and a portion of Moline Acres.


On May 17, 2016, Keith Goldstein was sworn in as the new Fire Chief of North County Fire & Rescue Protection District, formerly known as Riverview Fire Protection District. Chief Goldstein brings with him 30 years of experience in North St. Louis County. Chief Goldstein previously served Black Jack Fire Protection District for the last 30 years, where he served as a Battalion Chief for the last 10. He also served as a Fire Service Instructor for the last 10 years at the St. Louis County Fire Academy.

Chief Goldstein has a B.S. in Fire Science, from Columbia Southern University, as well as his Associates in Applied Science in Fire Protection Technology, from St. Louis County Community College.

He has served on numerous fire district committees and participated in many outreach activities, which he plans to bring to the Riverview Fire Protection District area.

His vision is for the community to see more interaction between the firefighters and citizens. Current plans include: delivering Christmas presents and meals to those in need, MDA Collections, Ice Creme Socials/Safety Awareness events, and partner with local schools for academic and attendance awards.




